# Public Health: What You Need to Know

# **RSV PROGRAM UPDATE**

- In late July, the Ministry expanded the Ontario routine immunization schedule for fall 2024 to include more infants, high-risk children and pregnant individuals for RSV vaccination.
  - The risk of severe outcomes from RSV infection is highest among infants under six months of age and children under 24 months of age with chronic conditions such as chronic lung disease, congenital heart disease, compromised immune systems, or neuromuscular disorders.
  - In alignment with the National Advisory Committee on Immunization, Beyfortus is the preferred product to protect infants. Receiving both Abrysvo and Beyfortus is not expected to provide additional benefits.
  - Sanofi's Beyfortus delivers passive immunization, providing protective antibodies to infants.
  - o Pregnant individuals should consult with their health care provider before receiving Abrysvo.

# INCOME THRESHOLDS FOR SENIORS DENTAL CARE

- Effective August 1, 2024, annual income eligibility thresholds for the Ontario Seniors Dental Care Program changed for:
  - Single seniors with an annual income of \$25,000 or less (previously \$22,200)
  - Senior couples with a combined annual income of \$41,500 or less (previously \$37,100)
