Plan ahead, order vaccine: Immunization of School Pupils Act (ISPA) Notifications and Suspensions

- Students, missing any mandatory immunizations or who have not provided records of receiving the mandatory immunizations, required to attend school under ISPA, will be suspended from school on May 16th, 2018.
- As a reminder, students born in or after 2010 must have received 2 doses of varicella vaccine or provide a completed medical exemption form to ESTPH by the deadline.
- You may experience an increase in the number of enquires about immunizations as we encourage students to check their records with their Healthcare Provider, then receive any outstanding immunizations, and report these immunizations to Elgin St. Thomas Public Health.

- The goal of the Healthy Growth Initiative is to collect comprehensive data on children from birth to 18 years of age in order to assist health care providers, public health units and policy makers in the promotion and support of a healthy lifestyle for all children in the province.
- Elgin St. Thomas Public Health is asking primary care providers (including nurse practitioners and family health teams) to share data that currently exists in their EMRs with BORN.
