Canada has a new food guide!

- Phase 1 of the new Canada's Food Guide was released in mid January.
- The new food guide uses up to date scientific research between food, nutrients and health.
- There has been a complete removal of the food guide portions and the four food groups.
- Focuses on the "Eat Well" plate that emphasizes more plant-based, whole and unprocessed food.
- Takes a firm stand against sugary drinks (including juice) and moderating alcohol.
- There is an emphasis on mindful eating as well as cooking, eating and enjoying food together.
- It reminds Canadians to use food labels to make better food purchasing decisions and to be more in tune with how food marketing strategies can manipulate their purchases.
- It leads Canadians towards a diet that is more moderate in sodium, sugars and saturated fat for chronic disease prevention.
- Phase 2 of the food guide is expected later this year. It will deal with healthy eating patterns for individual needs and specific nutrient issues (e.g. calcium).

Health Canada Alert regarding products sold at A1 Herbal Ayurvedic Clinic Ltd.

- Health Canada recently issued an alert regarding products sold at A1 Herbal Ayurvedic Clinic Ltd. in Surrey BC, with an affiliated clinic in Brampton, Ontario.
- There was one case of heavy metal toxicity in BC; none reported in Ontario.
- Health Canada inspectors have seized products, ingredients and equipment from these clinics and laboratory testing has confirmed the presence of lead and mercury.
- The seized products were unauthorized health products and illegal to sell in Canada.
